



How to Choose a Company Name

Words and Characters that are NOT considered Distinguishable:

"Company" Words or Abbreviations	Singular vs. Plural, Possessives	Punctuation, Special Characters, and Other Words
Company or Co.	Property vs. Properties	The
Corporation or Corp.	Goose vs. Geese	A
Limited Liability Company, Ltd Liability Co., LC, or LLC	Child vs. Children	And or &
Limited Partnership or LP	Cactus vs. Cacti	All punctuation is non-distinguishable.
Incorporated or Inc.	John vs. John's	Spacing: Wildwood vs. Wild Wood

To see if a name is available:

[Search](#) and compare only the **distinguishable words and characters** in the name you have in mind:

XYZ Inc. **X Y Z Corporation** **XYZ LLC** **¡XYZ! LLC**
X's YZ LLC **X-Y-Z Limited Liability Company**
XY and Z Limited Partnership **The XYZ Company Ltd.**
X. Y. & Z. LLC **XYZ Limited Liability Company**
XYZ's Co. **XYZ³ LLC** **XYZ\$Corp**

In each of these names we are left with only "X Y Z" to compare.

Filing Name

XYZ

Starts With Contains

XYZ, LLC - 2012-000622964 (LLC) Status: Active

Standing - Tax: Good Standing - RA: Good

None of the names above are available.

(Note that this company status is "Active." For "Inactive" companies, the name becomes available two years after the Inactive Date, which shows up if you click on the result. A name designated "(Old Name)" is no longer held for that company.)



How to Choose a Company Name

To make a name distinguishable:

Add at least one distinguishable character such as a numeral, a distinguishable letter, or an additional word:

XYZ **2** LLC

WXYZ LLC

XYZ **Ranch** LLC

Numerals, Roman Numerals, and number words **are considered distinguishable** from one another:

XYZ **3** LLC

XYZ **III** LLC

XYZ **Three** LLC

Name Requirements for Different Entity Types:

Many entity types have specific requirements for the entity name, such as: a **limited liability company** name must contain a form of "LLC"; a **corporation** name may contain "Inc." but is not required to, etc.
