## Qualifications for Holding Office

Pursuant to W.S. 6-10-106, a person convicted of a felony is incompetent to hold any office of honor, unless he has had a complete and full restoration of rights, not just voting rights. If you have any questions regarding your ability to hold office, please ask the County Clerk for clarification.

Please ensure that:

- ✓ You're not holding an office that may conflict, or be incompatible, with the office for which you are filing.
- ✓ Your employment is not incompatible with the office you are seeking.

### UNITED STATES SENATOR

- Must be at least 30 years old
- U.S. Citizen for nine (9) years
- An inhabitant of the state in which he shall be chosen (U.S. Constitution, Art. 1, Sec. 2)

### UNITED STATES HOUSE OF REPRESENTATIVES

- Must be at least 25 years old
- U.S. Citizen for seven (7) years
- An inhabitant of the state in which he shall be chosen. (U.S. Constitution, Art. 1, Sec. 2)

### GOVERNOR

- Must be at least 30 years old
- U.S. Citizen
- Qualified elector
- Resided in the state five years next preceding the election (Wyo. Constitution, Art. 4, Sec. 2)

### SECRETARY OF STATE, STATE AUDITOR, STATE TREASURER AND STATE SUPERINTENDENT OF PUBLIC INSTRUCTION

- Must be at least 25 years old
- U.S. Citizen
- Qualified elector (Wyo. Constitution, Art. 4, Sec. 11)

### STATE SENATOR

- Must be at least 25 years old
- U.S. Citizen
- Qualified elector
- Resided in the district from which elected at least twelve months next preceding his election  
W.S. 22-5-102(a)

### STATE REPRESENTATIVE

- Must be at least 21 years old
- U.S. Citizen
- Qualified elector
- Resided in the district from which elected at least twelve months next preceding his election  
W.S. 22-5-102(a)

In any general election year in which legislative reapportionment is required but has not been enacted into law at least one (1) year prior to the applicable filing periods, a person may be a candidate for the state legislature from a legislative district if he/she:

- (i) Is a resident of the legislative district on the date he files an application under W.S. 22-5-204 or a petition under W.S. 22-5-301; and
- (ii) Has been a resident of a county for at least one (1) year next preceding his election in which any portion of that legislative district is located.
