
## How To Use This Form

This version of the Contribution and Expenditure Campaign Finance Report is a fillable PDF form that includes additional features to help streamline the process of completing county and municipal C&E reports. Information can be typed, itemization pages added as needed, totals calculated with the click of a button, and e-signatures affixed. The completed form can then be saved and emailed to your County Clerk without ever needing to print.

To use this form, Adobe Acrobat Pro, Acrobat Standard or Acrobat Reader are <u>required</u>. If you do not have one of these programs installed, Acrobat Reader is available for free. After downloading this file, open and view it with Acrobat, not your Internet browser.


Adding Itemization Pages: After filling out the first page of the C&E form, you can add itemization pages that correspond to the transactions you need to itemize. To do this, select the appropriate 'Add' button, as shown to the right. IMPORTANT: Itemization pages cannot be deleted, so only add pages that you require for itemization!



After confirmation, an itemization page will be added to your report further down the document. Added pages will appear in an order that corresponds to the list on Section 5 of the first page of the report. For example, if you add an Expenditure page and then later add an Individual Contribution page, you will find the Individual Contribution page appears above the Expenditure page.

**Calculating Totals:** Fill out information relating to your transactions in the itemization page you have added, as shown in the screenshot below:

At any point while filling out itemized transactions, you may calculate the totals by selecting the 'Calculate' button from the first page, as shown at left. IMPORTANT: You must remember to select the 'Calculate' button after finishing with your itemizations, otherwise the totals that display on the first page will be incorrect!

**Affixing Signatures:** After you have filled all required fields, itemized your transactions, and calculated final totals, you can affix an e-signature by selecting the signature fields at the bottom of Page 1 of the form, as shown at right. If you have not previously configured an e-signature, clicking the signature field will also allow you to do that. *Note: Some counties may require you to provide an ink signature instead of an e-signature. If this applies to you, print out your C&E form and affix signatures by hand.*

### STATEMENT OF CONTRIBUTIONS AND EXPENDITURES Federal Political Action Committee W.S. 22-25-106 through 109

# This form is for FEDERAL POLITICAL ACTION COMMITTEES (PACs) that contribute to or expend funds to Wyoming local candidates (e.g., county or municipal candidates).

#### Who must file?

Candidates for federal office, campaign committees for candidates for federal office and <u>federal political action</u> <u>committees that are making contributions or expenditures only to federal candidates or for federal issues shall not</u> <u>be required to file contribution and expenditure reports under this section</u> if the candidate or the committee is required to comply with federal election law reporting requirements. W.S. 22-25-106(g)

#### What must be filed and when?

- A committee shall file <u>an itemized statement of contributions and expenditures</u> at least seven (7) days before the election up to the fourteenth day before the election. W.S. 22-25-106(b)(i)
- The committee shall file <u>any amendments to a filed report</u> within ten (10) days *after* a primary, general or special election. W.S. 22-25-106(b)(i)
- A committee formed after an election to defray campaign expenses incurred during a previous election, and any ongoing committee, shall file <u>an itemized statement of contributions and expenditures</u> on December 31<sup>st</sup> of each odd-numbered year and shall continue to make the reports until the committee terminates. W.S. 22-25-106(b)(ii)
- All reports required by subsection (b) of this section shall be signed by both the chairman and treasurer. The reports shall set forth the full and complete record of contributions including cash, goods or services and actual and promised expenditures. The date of each contribution of one hundred dollars (\$100.00) or more, any expenditure or obligation, the name of the person from whom received or to whom paid and the purpose of each expenditure or obligation shall be listed. Nothing in this subsection shall be construed to require the disclosure of the names of individuals paid to circulate an initiative or referendum petition. All contributions under one hundred dollars (\$100.00) shall be reported but need not be itemized. Should the accumulation of contributions from a person exceed the one hundred dollar (\$100.00) threshold, all contributions from that person shall be itemized. If the contributions, expenditures or obligations were for more than one (1) candidate, the amounts attributable to each shall be itemized separately. W.S. 22-25-106(c)

#### What are the filing deadlines for the 2024 election?

- Primary Election: Contributions & Expenditures 7 days before the Primary: Aug. 6 Aug. 13, 2024
- General Election: Contributions & Expenditures 7 days before the General: Oct. 22 Oct. 29, 2024
- Non-Election Year (odd-numbered year): Contributions & Expenditures: Dec. 31<sup>st</sup>
- Special Election: Contributions & Expenditures 7 days before the election

#### **Reporting requirements:**

The general rule is that a committee should note and keep track of all campaign contributions no matter how small. The law only requires you to itemize contributions on this form that total \$100 or more. However, keep in mind that if you receive \$80 from a contributor who then later gives you \$30, you must report the total \$110 contribution on this form.

#### Penalty for not reporting:

A person found guilty of violating Wyoming campaign finance statutes is subject to criminal charges. Failure to file a required report could result in a civil penalty of up to two hundred dollars (\$200.00) per day. W.S. 22-25-108(f)(ii).
