Application Instructions _____

- A Notary Public Commission is valid for a four year term. You must re-apply with our office every four years.
- Commission Renewals may be submitted up to six weeks prior to the term expiration date.
- Submit one Application/Renewal form with ink signature via mail to the address on the form.
- Filing fee of \$30.00. Make check or money order payable to Wyoming Secretary of State.

Next Steps _____

- Typical processing time is 3-5 business days following receipt of your documents.
- You may not notarize until all steps have been completed. Once your application/renewal is processed, you will receive a letter from our office advising you of the final requirements to complete the commission process as follows:
 - Obtain your \$500 notary bond covering the four year commission term.
 - Record your bond and oath with your County Clerk's Office within 60 days from the beginning date of your commission.
 - Your certificate will have been sent to the Clerk and you will receive it upon recording your oath and bond.
 - Then you may purchase your stamp and supplies, and begin notarizing.
